Seven & Mila Events SL informs you that the information you provide through the different means of this website in relation to the FIA WORLD RX CATALUNYA event. BARCELONA. SPAIN will be treated by it for the purposes and under the conditions detailed below, in accordance with Regulation (EU) 2016/679 of the European Parliament and of the Council, of April 27, 2016, concerning the protection of persons physical as regards the processing of personal data.

Data requested in forms

What data are we going to request?

Data collected from the purchase of tickets:

- Identifying information such as First and last name
- Contact information such as e-mail and telephone, to send the tickets purchased, inform you of any changes and setbacks that may occur related to the event, and to send future shows that may interest you.
- Data related to gender and location, optional for statistical and segmentation purposes.
- Date of birth. Seven & Mila Events SL reserves the right not to sell tickets and withdraw those acquired by minors under 18 years of age.
- Economic data bank card

Data collected from information request forms "Contact" or through the different means of contacting the web:

- Name, email and those that are derived from your request, in order to respond to it correctly.

When completing forms, the optional data will be indicated as such, the rest being mandatory, so that if you do not provide them, the processing of your request will not be possible.

You will be solely responsible for their being truthful, for the damages caused by the lack of truthfulness and for keeping your information updated.

Purposes and Lawfulness

Your personal data may be processed for the following purposes:

(1) **Management derived from the sale of tickets.** Manage the contracting of the services offered through the Website. During the contracting process, financial data (bank cards) may be collected for the purpose of communicating them to the entities that manage the collection or contracting specific insurance (for example, cancellation of events).

The legal basis for the processing of your data for this purpose will be the execution of the purchase contract carried out at the request of the User, with the necessary treatment for this purpose.

(2) **Sending information related to the event.** We may contact the User in order to inform him of any change or novelty related to the event he attends or to remind him of his next event. The sending of this type of communications responds to the execution of the ticket purchase contract, being the necessary treatment for this purpose.

(3) **Sending information on successive events** organized by Seven & Mila Events SL, including future FIA WORLD RX CATALUNYA events and information on FIA WORLD RX that is played worldwide. We may send you communications related to successive events organized or in which Seven & Mila Events SL participates. The sending of this type of communications is based on the legitimate interest of Seven & Mila Events, protected by art. 21 of the Law on Services of the Information Society and Electronic Commerce (LSSICE)

(4) **Realization of statistics that allow knowing the typology of the attending general public.** The realization of statistics obeys the legitimate interest of the Organizer without violating the rights of Users.

(5) **Perform segmentation procedures that allow to customize the offer of services appropriate to the needs of its users (territory).** The realization of this type of procedures is based on the legitimate interest of the User and their consent. Said acceptance will not imply the making of automated decisions.

(6) **Respond to as many requests for information from the User that we may receive.** The legitimate basis of the processing of your data will be established by your consent and your own interest.

Assignments

Your information will not be transferred to third parties without your prior consent, except for those communications necessary for the management of the purposes described. In this sense, they will have access to it:

The entities that manage the collection or contracting of specific insurance.

Circuits de Catalunya SL, entity that hosts the celebration of the event, responsible for the control of access and capacity to the same. In this case you will have access to the data that you request in the identity verification as a buyer of the tickets in the access to the site. Seven & Mila Events will not provide any personal information, only transmitting the number of global locations acquired.

OneBox Ibérica SL owner of the ticket purchase platform.

With these entities Seven & Mila Events has adopted the necessary agreements in the protection of the confidentiality of information.

In any case, there will be no international transfers of data or third countries with a level of security not comparable to the European one in application of Regulation 2016/679 of the European Parliament and the Council of April 27, 2016 (RGPD), on protection of natural persons regarding the processing of personal data.

Conservation of data

Your data will be processed during the indispensable time being eliminated after the conservation periods:

Data derived from the economic transaction: During the periods of mandatory custody established by Law 58/2003, of December 17, General Tax or current regulations, as the case may be.

Contact data collected in the acquisition of locations: Your contact data such as email will be kept indefinitely for the purposes of communications of goods and services as long as you do not oppose or revoke the consent.

Data provided through the completion of the "Contact" form or any means of requesting general information: Your data will be kept only to process your request for information. Once this has been done, your data will be deleted.

In any case, the data provided will be kept as long as legal liabilities could arise.

Security of the information

Your data will be hosted on servers owned by Seven & Mila Events located in the facilities with as many security measures as are necessary to safeguard the confidentiality of the mimes and avoid undue access, according to regulatory compliance.

Rights of Users

As owner of the information provided you can exercise the rights of access, rectification and cancellation of your data, oppose the processing of these for sending commercial communications, limit the processing of your data, or request portability in those cases provided, no longer be subject to automated decisions through the following means: info@sevenmila.com

The exercise of rights must be carried out by the owner of the information or legal representative, by means of a written document accompanied by a DNI.

Seven & Mila Events SL will have a maximum period of ONE MONTH to respond to your request, according to Art. 12 RGD.

In case your rights are not satisfied you can file a claim with the AEPD - Spanish Agency for Data Protection, Calle Jorge Juan, 6, 28001 Madrid.
